CLASS REPRESENTATIVE'S UNOPPOSED NOTICE TO THE COURT REGARDING PROPOSED SCHEDULE FOR CLASS COUNSEL'S NOTICE AND MOTION FOR ATTORNEY'S FEES, LITIGATION EXPENSES, AND CASE CONTRIBUTION AWARD

On November 18, 2022, Class Counsel provided a proposed schedule for notice and briefing related to attorney's fees, litigation expenses, and a case contribution award. *See* Dkt. No. 577 at 6.
